**CHANGES TO THE JANUS HENDERSON HORIZON ASIA-PACIFIC PROPERTY EQUITIES FUND AND IMPACT ON YOUR RL360 PLAN - <PRODUCT> <PLAN NUMBER>**

Janus Henderson has advised that it is making some changes to its Horizon Asia-Pacific Property Equities fund on 1 July 2020 that your plan invests in so we wanted to make you aware of the changes and explain your options for switching to a different fund if you prefer.

**Change of fund name**

The fund name will be amended from 'Janus Henderson Horizon Asia-Pacific Property Equities' to 'Janus Henderson Horizon Asia-Pacific Property Income'.

**Change of investment policy**

The investment policy will be updated according to the change of name of the fund.

Janus Henderson have seen a declining interest in the fund's current strategy coupled with growing interest in income focused strategies. It has therefore decided that the fund's revised objective and strategy towards an income focus is a more compelling proposition going forward.

**Your options**

If you are happy with these changes, you don't need to do anything. However, if you would prefer to switch to a different fund available to your plan, it's free of charge, and very easy to do. You may want to discuss the options with your financial adviser before deciding.

<p>The investment objective of the fund is to seek long term capital appreciation by investing at least 75% of its assets in the quoted equities of companies or Real Estate Investment Trusts (or its equivalents) in the Asia Pacific Region.</p>	<p>The fund's investment objective will change to provide a sustainable level of income, with a dividend yield higher than that of the FTSE EPRA Nareit Developed Asia Dividend Plus Index, plus the potential for capital growth over the long term.</p> <p>The fund will be actively managed with reference to the FTSE EPRA Nareit Developed Asia Dividend Plus Index (the "Index"), which is broadly representative of the companies in which it may invest.</p> <p>However, the investment manager has the discretion to choose investments for the fund with weightings different to the index or not in it, but at times the fund may hold investments similar to it.</p> <p>The index will form the basis of the fund's income target as stated in the fund's revised investment objective, and the level above which performance fees may be charged as explained below.</p>
